The Department of Education (DepED) Division of Panabo City, through the CY 2018 Basic Educational Facilities Fund – Repair of Classrooms, intends to apply the sum of **Five Million, Six Hundred Seventy-Six Thousand, Three Hundred Thirty-Nine Pesos and Eighty-Five Centavos only (PhP 5,676,339.85)**, being the Approved Budget for the Contract (ABC), to payments under the contract for the Repair and Rehabilitation of School Building at New Visayas Elementary School, Rizal Elementary School and Sta. Cruz Elementary School.

The **DepED Division of Panabo City**, through its Bids and Awards Committee (BAC), now invites bids for the above-mentioned works. Prospective bidders must have an experience of having completed at least one (1) contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships/partnerships, or organizations with at least seventy five percent (75%) interests or outstanding capital stocks belonging to citizens of the Philippines

A complete set of Bidding Documents may be inspected or purchased at the **DepEd Division of Panabo City BAC Secretariat**, located at **DepEd, Division Office Building** upon accomplishing a bidder's information sheet and payment in cash of a non-refundable fee by interested bidders in the amount of

Six Thousand Pesos (P6,000.00) only to the DepED **Division Cashier**. Only bidders who purchased the Bidding Documents will be allowed to submit bids (ITB 6.8).

Pursuant to Panabo City Division BAC Resolution No. 41, s 2017 bidders outside Davao should have a satellite office in Davao Region


